

COMPETITION RULES

Experience

Article 1: Organization

EPIC MERIBEL TOURISME, hereinafter referred to as "The Organizer", whose head office is located at Maison du Tourisme - Office du Tourisme 510 route Albert Gacin, BP 1, 73550 Méribel-Les-Allues, registered under SIRET number 49981820100018, is organizing a free game with no obligation to purchase from 06/10/2025 to 26/10/2025 midnight (day included).

The Organizing Body provides the website <https://experience.meribel.net> (hereinafter "the Site").

The Organizing Body offers participants the chance to discover and win a stay in Méribel, which will enable one winner to win a 7-night winter stay for 4 people.

Participants will be asked to fill in an entry form and answer two questions to enter the competition.

Each participant will have one chance to win the prize.

Participation in the competition implies unreserved acceptance of the present rules in their entirety (hereinafter referred to as "the Rules").

Article 2: Participants

This free, no-obligation game is open exclusively to adults of any nationality on the date the game begins.

Persons who do not meet the above conditions are excluded from the game, as are members of the staff of "L'organisateur", and any person directly or indirectly involved in the design, production or management of the game, as well as their spouses and family members: direct ascendants and descendants or other relatives, whether or not living under their roof.

"The organizer reserves the right to ask any participant to provide proof of the above conditions. Any person who does not meet these conditions or who refuses to provide proof will be excluded from the game and, in the event of winning, will not be entitled to his or her prize.

Only one entry per person (same name, same address) is permitted. "The organizer reserves the right to verify compliance with this rule.

Participation in the game implies full acceptance of the present rules.

Article 3: Terms of participation

Participants must go to the following URL address:

The Game will take place exclusively via the <https://experience.meribel.net> website dedicated to the "Experience" Game (all other modes of participation - in particular postal - are excluded) from Monday, October 6, 2025 at 00:00 a.m. to Sunday, October 26, 2025 at 11:59 p.m. inclusive, French date and time of connection being taken as proof.

During the competition, the participant must complete a form and answer two questions.

The participant must fill in the information form completely and correctly for his/her registration to be validated. The player is informed and accepts that the information entered in the registration form is proof of identity.

If the participant takes part in the competition via an Instagram stories promotion, then the participant will have 3 times more chance of winning.

Any participation made contrary to the provisions of these rules will render the participation invalid. Any participant suspected of fraud may be dismissed from the competition by the "Organizer" without justification. Any identification or participation that is incomplete, erroneous or illegible, whether intentionally or not, or made in a form other than that provided for in these rules, will be considered invalid. The same penalty will apply in the event of multiple entries.

Article 4: Winnings

The prizes at stake are distributed as follows:

A free winter week (7 nights from 27/12/25 to 03/01/26) for 4 people in a Label Méribel apartment (3 bedrooms) located in the heart of Méribel + 4 3 Vallées ski passes valid for 6 days.

Value of prize: €6,100 incl. VAT.

The value of the prizes is determined at the time of writing and cannot be contested.

All costs incurred after the game, in particular for the maintenance and use of these prizes, are entirely at the winner's expense.

Article 5: Designation of winners

At the end of the competition, the draw will take place on 03/11/2025.

Article 6: Announcement of winners

- Winners will be notified by e-mail to the address given when registering for the competition.
- The voucher will be given to the winners following their request by e-mail. It is not possible to change the dates of the stay. If the e-mail address is incorrect or does not correspond to that of the winners, or if for any other reason linked to technical problems, the winners' e-mail cannot be forwarded correctly, the Organizing Body cannot be held responsible under any circumstances. Similarly, it is not the responsibility of the Organizing Body to search for the contact details of the winner who cannot be reached due to an invalid or illegible e-mail address, or an incorrect postal address.

Article 7: Delivery of prizes

The prizes will be sent to the postal address indicated by the participants.

In the event of undelivered returns, the prize will remain at the participant's disposal for 10 days. After this period, it will no longer be available.

The winners agree to accept the prizes as offered, without any possibility of exchange, in particular for cash, other goods or services of any kind whatsoever, or transfer of the benefit to a third party. Likewise, these prizes may not be the subject of requests for compensation.

"The organizer reserves the right, in the event of an event beyond its control, notably linked to its suppliers or to unforeseeable circumstances, to replace the prizes announced with prizes of equivalent value. The winner will be informed of any changes.

Article 8: Use of participants' personal data

Participant information is recorded and used by "The Organizer" to memorize their participation in the contest and to award prizes.

Participants may, for legitimate reasons, object to their personal data communicated in the context of this game being processed. They also have the right to object to their personal data being used for commercial canvassing purposes, outside the scope of participation in this competition, which they can exercise as soon as their participation has been registered, by writing to "L'organisateur" at the address given in article 1.

The winner(s) authorize "L'organisateur" to use their contact details (surname, first name) for advertising or public relations purposes, in any medium whatsoever, without this conferring on them any remuneration, right or advantage whatsoever, other than the award of their prize.

In accordance with the French Data Protection Act (Loi Informatique et Libertés) in its latest version, as well as Regulation n°2016/679 of the European Parliament and Council of April 27, 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data (RGPD), the participant may exercise his/her right to access, rectify, delete data, limit processing, his/her right to data portability, his/her right to object, as well as his/her right to withdraw consent by writing to "The Organizer" whose address is mentioned in Article 1.

Article 9: Game rules

Article 10: Industrial and intellectual property

The reproduction, representation or exploitation of all or part of the elements making up the game, including these rules, is strictly forbidden.

All trademarks, logos, texts, images, videos and other distinctive signs reproduced on the site, as well as on sites to which it provides access via hypertext links, are the exclusive property of their owners and are protected as such by the provisions of the French Intellectual Property Code for the entire world. Their unauthorized reproduction constitutes an infringement punishable by law.

Any total or partial unauthorized reproduction of these trademarks, logos and signs constitutes an infringement punishable by law.

Participation in this game implies full acceptance of the present rules by the participants.

Article 11: Liability

The organizer cannot be held responsible in the event of force majeure or unforeseen circumstances beyond its control. "The organizer cannot be held responsible for delays, loss, theft, damage to mail, or illegibility of postmarks due to postal services. Nor shall it be held liable, and no recourse may be taken against it, in the event of events presenting the characteristics of force majeure (strikes, bad weather, etc.) partially or totally depriving participants of the opportunity to take part in the game and/or the winners of the benefit of their winnings.

The "organizer" and its service providers and partners may under no circumstances be held liable for any incidents that may occur in the use of the prizes by the beneficiaries or their guests once the winners have taken possession of them.

Likewise, the "Organizer" and its service providers and partners cannot be held responsible for the loss or theft of prizes by the beneficiaries once the winners have taken possession of them. Any additional cost required to take possession of the prizes shall be borne entirely by the winners, who shall not be entitled to claim any compensation whatsoever from "The organizer" or its service providers or partners.

Article 12: Disputes & complaints

The present rules are governed by French law.

The "Organizer" reserves the right to rule without appeal on any difficulty that may arise in interpreting or applying these rules, it being understood that no dispute will be admitted, particularly on the terms of the game, the results, the winnings or their receipt, one month after the end of the game. Except in the case of obvious errors, it is agreed that the information resulting from the game systems of "The Organizer" have probative force in any dispute as to the elements of connection and computer processing of said information relating to the game.

All claims must be sent to "L'organisateur" within one month of the end of the game. After this date, no claim will be accepted. Participation in the game implies full acceptance of the present rules.

Article 13: Evidence agreement

By express agreement between the participant and "L'organisateur", only "L'organisateur"'s computer systems and files will be deemed authentic.

The computerized registers, kept in the computer systems of "The organizer", in reasonable conditions of security and reliability, are considered as proof of the relations and communications between "The organizer" and the participant.

It is therefore agreed that, in the absence of manifest error, "The organizer" may rely, in particular for the purposes of proof of any act, fact or omission, on programs, data, files, records, operations and other elements (such as tracking reports or other statements) of a computer or electronic nature or format or medium, established, received or stored directly or indirectly by "The organizer", in particular in its computer systems.

The elements considered thus constitute proof and if they are produced as means of proof by "The organizer" in any litigation or other proceedings, they will be admissible, valid and opposable between the parties in the same way, under the same conditions and with the same probative force as any document that would be established, received or kept in writing.

Operations of any kind carried out using the identifier and code allocated to a participant, following registration, are irrevocably presumed to have been carried out under the participant's responsibility.
